MOTOR VEHICLE PERMIT REGULATIONS

- SEASONAL PERMITS (resident, business, fishing or medical) can only be issued by Council.
- SEASONAL PERMITS and/or TEMPORARY PASSES **will not** be issued to accommodate property owners who have recently established a permanent residence in the *Vehicle Restricted Area*.
- PERMITS and/or PASSES are to be used strictly for the approved purpose and are non-transferable.
- SEASONAL PERMIT holders are required to park their vehicles in the Municipal Parking Lot at all times, unless otherwise specified.
- TEMPORARY PASSES will be issued for the following purposes only:
 - Business: Trades people such as carpenters, electricians, plumbers, home care workers, etc., who are working at a specific location within the *Vehicle Restricted Area*
 - Medical: Individuals with serious medical conditions or severe physical impairment. At the discretion of Council. A note from a doctor may be required.
 - Deliveries: Vehicles with signage making deliveries within the *Vehicle Restricted Area*.
- TEMPORARY PASSES **will not** be issued for personal delivery of large loads.
- TEMPORARY PASSES are to be used strictly for business, delivery or medical purposes and vehicles must vacate the *Vehicle Restricted Area* **immediately** following completion of the authorized task.
- Misuse of the TEMPORARY PASS or PERMIT, including failure to display the PASS or PERMIT or any other applicable conditions of use, will result in fines and immediate cancellation of the PASS or PERMIT.
- Disputes regarding the issuance and/or use of PERMITS or PASSES must be referred to Council for its review and determination.
- ABUSE of the Gate Attendant will not be tolerated at any time. The VB Police will be contacted if required.
- Speed limits must be adhered to at all times and will be strictly enforced by the VB Police.
- **THE GATE INFORMATION PERSONNEL ARE APPOINTED BY COUNCIL TO ASSIST WITH THE REGULATION OF VEHICLE ACCESS TO THE *VEHICLE RESTRICTED AREA*. THEY ARE REQUIRED TO ENFORCE THE ABOVE-DESCRIBED REGULATIONS AND DO NOT HAVE THE AUTHORITY TO WAIVE ANY OF THE REQUIREMENTS.**
