# **OPS READY Emergency Software**

# Res. 2025/088 – Chadsey / Axworthy

Whereas wildfire risks to the RM of Victoria Beach are increasing every year and managing or preventing these risks is becoming more challenging; AND

Whereas there are software packages available that will enable map-based planning to support emergency preparedness and will enable streamlined information sharing in the event of a wildfire in the region;

- 1. Mapping of trails, routes and values
- 2. Emergency Plan storage
- 3. Incident initiation
- 4. Emergency Alerting
