  - Removal of acres of forest
  - Only one entry point into this Vehicle Restricted Area subdivision leading to confusion for visitors and difficult to enforce VRA restrictions
  - Drainage issues in this area will worsen with more development
  - Public Hearing for new road was scheduled after Conditional Approval was granted contradicting Planning Act procedure
  - Proposed idea Council should offer to buy property and convert to greenspace
  - o Submitted petition to revoke conditional approval of subdivision
