4. DELEGATIONS – Proposed removal of sandbags and replacement with toe protection revetment along King Edward and Alexandra Beaches paid for by shoreline owners

Andrew Smith

- Any proposed structure needs to be designed and certified by an independent geo-technical organization and all costs and long-term responsibilities must be finalized prior to implementation.
- As experts predict that any hard structure placed on a dynamic sand beach will result in the loss of the beach, it must be accompanied by ongoing sand replenishment. This cost could be borne by the community if the above noted conditions are met.
- This is precedent setting in our RM and as other reaches will be sure to follow, this project cannot proceed until these conditions are resolved.

Gord Patton

- Why is Council visiting this issue again from 2010/2011?
- Revetments hasten erosion (of beaches)
- Why such urgency? Wants science-based revetments
- Joanne Gibson (replaced Sean Taylor)
 - Does not want history repeating itself
 - Wants community cooperation
 - Calls for shoreline management committee to return and rules enforced along shoreline regarding cutting of vegetation and private structures

• Linda Kliewer

- Acknowledges shoreline owners need to protect their property
- Beaches need to be protected as well
- Use revetment guidelines from Baird report, need engineering stamp on proposal

• Andrew Stelmack

- Sympathetic to the shoreline owners but equally for those not on the shoreline. A win-win solution is needed, like the sandbags did for a decade. Replace them.
- If the revetment is to address mother nature it can only go forward with guaranteed sand replenishment and nourishment as Baird and science says.



 To address the human causes for erosion new laws must be created, suggested the new Zoning By-law as a place for them. To refute a councillor's challenge that the Arthur revetment has not caused damage offered to follow up with photo evidence to the contrary.

Blake Taylor

- Refers to Baird report for potential mitigation options and risks
- Beaches are large in 2023 due to low lake levels
- o Impacts of revetment causing beach loss could result in litigation

Mike Mason

- o Refers to Shoreline Management Plan for RMVB
- Toe protection in conjunction with nourishment is required
- Suggests replacing with new sandbags and monitor effects going forward

Council, comments and questions

- Proposed removal of sandbags and replacement with toe protection revetment along King Edward and Alexandra Beaches was presented to Council on 22 August 2023 where no decision has been made as Council is seeking more input from residents, Crown land representatives and other input where possible.
- A possible issue is that further erosion of banks will eventually cause beaches to move onto private property.
- Who pays for sand replenishment, RM or shoreline owners?
- Referring to previous Councils: why was nothing done as result of the Board report and the suggestions stemming from it? Mitigation cost for a few reaches were over \$1.5M and over \$8M for all reach recommendations.
- Sandbag placement originally was met with much resistance, now appear to be the accepted remedy. It is possible the "science" is not 100% accurate in some cases.
