Sally Lawler presented to Council a concern for emergency healthcare in the RM as a result of a recent incident. These concerns are a direct result of the changes in emergency services legislation brought about on 01 Dec 2020 by Manitoba Health, which increased Emergency Medical Responder and Paramedic License requirements. Sally has proposed the RM take a leadership position in local emergency healthcare, which would involve the direction and support of strategic locations/placements of Automatic External Defibrillators (AEDs) around the RM, their locations to be posted and communicated to residents, the provision or funding support for courses available to the community for AED training, recognized CPR & First Aid training and the improvement of emergent healthcare communication with residents. Advise residents of the First Responder issue via VB Herald, Website. Update health care resources on our website – in our community, Pine Falls, Selkirk, VB Summer Doctors.
