Whereas the current highwater levels of Lake Winnipeg has led to severe erosion of dikes in and around Wanasing and Albert Beach;

**Therefore, Be It Resolved** to approve immediate pre-emptive measures be taken to prevent damages to properties by restoring the dikes at Wanasing and Albert Beach.
