Delegation: Regarding RMVB ORV BYLAW 1614, RMVB enforcement

#### 1 Rob Monkman, VB resident

- Wants community collaboration;
- Speak up and let your voice be heard;
- ORV restrictions limit access to lake from VB property for work and recreation.

#### 2 Blake Taylor, President VBCOA

- VBCOA mandate is to preserve character and unique history of the VRA;
- Understands other areas of VB have different community interests;
- VBCOA is open to compromise; quotes by R. Moreau (RMVB CAO for 30 years) were read.

#### **3** Graham Cameron, VB resident

- Outdoor recreation over winter is healthy and needed by many;
- Snowmobiles have enjoyed access to lake and trails from within VB for over 60 years, why the change now?
- Local business is being affected negatively and states some issues are being over-exaggerated against the use of snowmobiles.

## MINUTES

#### 5 Rene Degagne, VB Snowdrifters

- Overview of Snowdrifters history with over 193 members (~30 from VB);
- Snowmobile safety and training is high priority for all;
- Funding for a lightweight rescue trailer is on-going.

#### 6 Dr. Paul Cooley, VB resident

- Resident since 1970's and thanks Council and Public Works for services provided;
- ORV restrictions limit access to lake where he works for the Federal government studying ice conditions;
- Understands issues from both sides and wants good relationship with police and Council and hopes BYLAW 1614 can be amended to allow ORV access so businesses can operate and people can enjoy safe outdoor recreation.

#### 7 Luc Perrin, VB resident

- A VB resident who wants to enjoy cottage life to the fullest and the ORV bylaw limits this enjoyment;
- No desire to drive on roads, only needs to be on roads for egress/regress to lake and trails that are nearby;
- Questions the need for the swing gates and wants BYLAW 1614 amended.

#### 8 Jerry Bourassa - Saffies General Store

- History of store and challenges faced by store in the off-season;
- BYLAW 1614 is causing harm to business due to lower customer volume as a result of Snowdrifters seeing VB as a place that is not very welcoming to snowmobilers;
- Provided a petition signed by many who support changes to BYLAW 1614.

#### 9 Kevin Ateah, VB Resident

- A long-time resident who recalls over the years never having any issues with snowmobiles in VB, why have things changed?
- Stresses the importance of residents being allowed ORV egress/regress from property to trails and lake and says he feels like a "criminal" now when he is on his snowmobile;
- Raised questions about the ORV Act, Snowmobile Act and VB Bylaws.

#### **10 Patti Ulrich/Matt Metcalfe (video);** VB resident

- Residents need access to lake and trails from properties;
- Stresses the VRA and rest of VB are different and this requires attention when forming VB bylaws;
- Having to trailer snowmobiles to get from property to trails or lake is unnecessary, cumbersome and will get very expensive for many residents.

2) to help understand the requirement for an RMVB ORV BYLAW to transfer the governance of ORVs on RMVB roadways from the ORV Act to RMVB, and3) to understand the authority of the VB Police Board and the VB police to enforce RMVB bylaws without Council direction or influence.

BE IT RESOLVED to approve 1st reading of BY-LAW NO. 1643 to amend By-Law 1614: A By-Law to regulate the use of Off-Road Vehicles (ORVs) within the Municipality. *Carried 5F/OA*
