Items Discussed:

The following correspondence was received:

- There was a presentation from the Lakeshore Property Owners Association with respect to the RM paying their Legal Fees for a recent Municipal Board Hearing.
- The Victoria Beach Permanent Residents Association expressed concerns over how roads are selected and • prioritized for Dust Abatement. A written response will be provided in the near future.
- Council encouraged citizens, to go to our website, to sign up for E-News. •
- Ownership of Provincial Highway #504, North of Olafsson continues to be discussed. A citizen expressed his support of a boat launch remaining at this location.
- A citizen inquired about reviewing the specifications for the geotechnical work being undertaken to create a permanent flood protection dike at Albert Beach. This individual was told to contact the RM office.
- A query from a citizen with respect to AED availability in Police vehicles.
- A ratepayer raised concerns about Ash Trees on private property dying. The RM has no policy with regards to trees on private property.
- The Bakery is not yet completed and there are a few outstanding items.
- Council is considering hosting the North Eastman Regional Municipal Forum in 2018. Dates and location to be determined.
- Several citizens expressed their concerns with respect to 911 call outs and associated response times. Concerns were also raised with respect to coordination and communication between the Fire and Police Services.
- Naming the paths in our community was discussed.
