Res. 2023/046 – Chadsey / Randle

Be It Resolved that the Agenda be adopted with the following additions: Storage container purchase, ORV survey. ***Carried 4F/0A***

Res. 2023/047 – Chadsey / Randle

Be It Resolved that the minutes of the February 21st, 2023 regular council meeting be adopted as presented. ***Carried 4F/0A***

Delegations:

1. Laura Jones, Shoreline Erosion

- Worried about increased intensity and frequency of storms causing erosion.
- Presented picture of King Edward beach erosion.
- A solution is needed now to protect developed properties.
- Asking Council to agree that shoreline protection is essential and leaving as-is is not a solution.

2. Nicole Toews, ORV bylaw

- A long-time resident of Albert Beach whose family are avid snowmobilers and they moved to the area to enjoy this winter recreation activity and she was aware of the bylaws at the time.
- Now, with the recent bylaw changes, they trailer snowmobiles to access trails and they see more police cars and police tape in the area.
- Asking for egress/regress permission to access trails and lake.

3. Graham Cameron, ORV bylaw - virtual

- Refuted the claim that ORVs in area cause more break-and-enters and that property values decrease because of ORV use; facts do not support these claims.
- Wants to solve this ORV issue maturely and do away with the factions that are dividing the community.
- Not in favour of grand-fathering permitted uses of ORVs and
- Not in favour of issuing VB special permits to ORV operators.

4. Ian Fish, ORV bylaw

- Wants to stop arguing back and forth and use facts free from “confirmation bias” to support any bylaws going forward, referring to delegations at the 21 Feb 2023 Council meeting.
- Stated ORV use was not in the top 10 reasons for cottage fires and suggested other activities in VB pose more risk for fire.
- Stated noise pollution caused by ORVs at 20km/hr is lower than chainsaw use or even large gatherings of people.
- Wildlife migration changes (deer) are more affected by pedestrian activities than snowmobiles.

5. Jerry Bourassa, ORV bylaw

- States Council needs to be responsible to all residents and BYLAW 1614 was a failure for many residents of VB.
- BYLAW 1643 first reading draft was weak and does not solve the issues.
- Suggests ORV restriction time period should match the VRA period and that Saffie Road should be open to ORVs all year.
- AB2VB trail portion is only safe route for ORV travel and wants Council to work with interested user groups to find solution and offered support.

Petition: A sufficient petition signed by 273 residents of VB (*verified by CAO*) is presented to Council regarding ORV use in the municipality and reads as follows:

Be it resolved that we the undersigned propose either an addendum to Bylaw 1614 or a new Bylaw to replace Bylaw 1614 allowing for the following:

- *Legal egress and regress for ORVs to and from our RMVB properties to access the SnoMan trails or the lake in winter for ice fishing.*
- *Legal egress and regress for ORVs to and from our RMVB properties to access the ditches of PR 504 and PTH 59 to allow safe passage to the ORV trails in the RM of Alexander and beyond.*
- *Legal access to and from Saffies Store on Saffie Road and Rue Girard to purchase gasoline, food, and supplies as required.*
- *A speed limit of 20KPH for the above noted on Municipal Roadways.*
